About 1993 my son, MARCUS HENRY CHAPMAN, was convicted of MURDER. HE got up in COURT taking THE WHOLE BLAME FOR IT, BECAUSE MARCUS BELIEVED HE WOULD BE KILLED IN PRISON FOR BEING A SNITCH.

THE guard that RAPED him WAS ON THE ORIGINAL LAWSUIT AGAINST THE STATE OF Ill. FOR SOME REASON HE WAS TAKEN OFF.

I did not know that our PRISONERS WERE put THERE to be TORCHERED.

I found out AFTER my son died, that the PRISON GUARD in ORIGINAL LAWSUIT AGAINST THE STATE WAS ALSO the guard that was on

duty there in Tamms the night MARCUS' hanging.

It wasn't enough that MARCUS was in a cell to live and let out a short time in a cage that was below ground, that all he could see was the sky.

Animals in a kennel are treated better than that.

I believed that when that guard transferred from Stateville to Tamms is why my son died. HE WAS PROBABLY BEING RAPED ALL OVER AGAIN.

HE TRIED GETTING HELP FROM THE DOCTORS THERE. BUT THEY MADE HIM STRIP DOWN TO NAKEDNESS WITHOUT SO MUCH AS A BLANKET TO KEEP WARM. WHAT KIND OF A PLACE IS THAT?

A TORTURE CHAMBER?

I DON'T BELIEVE FOR ONE MINUTE THAT HIS DEATH HAPPENED THE WAY

They said at the inquest,  
I believe the nurse that  
was on duty is just as guilty
